  - any concessions by Stevenson to the Customer or to any other Guarantor; or
  - the insolvency of the Customer or any other Guarantor; or
  - any other act, omission, or rule of law which, were it not for this clause, might release a guarantor; and irrevocably waives any rule of law to a different effect.
- Acknowledge that Guarantor has been advised to seek independent legal advice in relation to the obligations under this Personal Guarantee and has either done so or elected not to do so prior to signing this Guarantee
- Authorises Stevenson to collect personal information and/or provide personal information relating to the Guarantor to credit reference agencies, referees and other bodies, as Stevenson considers necessary for the purposes of the Guarantee. The Guarantor has the right to access and correct any personal information held by Stevenson.
